AGREED AMENDED SCHEDULING ORDER

On November 15, 2016, Resolution Judge Honorable H. Charles Carl, III conducted a post-mediation status conference, at which the Court and counsel for both parties appeared by telephone. Counsel advised the Court that, following the parties' October 31, 2016 early mediation, Defendant agreed to provide supplemental discovery to Plaintiff. Thereafter, Defendant made disclosures to Plaintiff on November 4 and 10, 2016.

In light of these disclosures, counsel jointly moved the Court to extend the Scheduling Order deadlines for a period of thirty (30) days. Judge Carl agreed that such an extension appeared to be warranted, and he offered to inquire whether Presiding Judge Honorable Russell M. Clawges would grant such a request. Judge Clawges advised Judge Carl that a 30-day extension of the Scheduling Order deadlines is warranted under these circumstances. Accordingly, the Court **GRANTS** the parties' joint motion to extend Scheduling Order deadlines, and those deadlines are extended for thirty (30) days, as follows:

1. **Trial Date:** to be set at pretrial
2. **Pre-Trial Conference Date:** February 21, 2017 at 1:00 pm
3. **Dispositive Motions:** February 13, 2017
4. **Discovery Completion Date:** January 30, 2017

5. **Motions in Limine:** February 13, 2017
6. **Mediation/Alternative Dispute Resolution:** On or before February 8, 2017

It is so **ORDERED**.


