**AGREED ORDER SETTING/EXTENDING CERTAIN DEADLINES IN THE
CURRENT SCHEDULING ORDER**

On June 7, 2019, came the Parties and agreed that the Court should amend the Scheduling Order of July 6, 2018, in this matter to accommodate the following new deadlines:

1. Allowing until July 26, 2019, for the supplementation of Plaintiff's expert reports;
2. Allowing until August 9, 2019, for the supplementation of Defendants' expert reports;

3. Allowing for conducting discovery of expert witnesses until September 13, 2019;
4. Extending the deadline for the filing of dispositive motions until September 30;
5. Extending the deadline for responding to dispositive motions until October 30, 2019;
6. Extending the deadline for replying to responses to dispositive motions until November 15, 2019; and
7. Extending the deadline for scheduling and concluding mediation/alternative dispute resolution completion by December 15, 2019.
8. That all other dates set forth in the Scheduling Order of July 6, 2018, shall remain unchanged.

Pursuant to the agreement of the Parties, it is hereby **ORDERED** that the Scheduling Order of July 8, is hereby amended to include the foregoing dates, and that all other dates in the Scheduling Order of July 6, 2018, shall remain unchanged.

The Court further **ORDERS** that the Clerk forward a copy of this Order to all counsel of record.


