**AGREED ORDER SETTING/EXTENDING DEADLINE FOR THE FILING OF  
PRE-TRIAL MOTIONS**

On January 13, 2020, came the Parties and agreed that the Court should amend the Scheduling Order of July 6, 2018, as follows:

Per the Court's Order of November 12, 2019, the case is now set for trial commencing June 8, 2020 with a final pre-trial hearing set for May 8, 2020.

1. Pre-trial Motions, per the Court's Scheduling Order of July 6, 2018, are to be filed on or before January 24, 2020.

2. The parties are presently preparing mediation statements, which are due on or before January 15, 2020, with mediation set for January 30 and 31, 2020, in Charleston, WV.

3. Accordingly, the Parties have requested that the Court amend the Scheduling Order to require the filing of pre-trial motions on or before **April 10, 2020** with responses due by **April 24, 2020**.




