**ORDER DENYING DIRECTIONAL ONE SERVICES INC. USA'S  
MOTION IN LIMINE AND/OR MOTION TO COMPEL  
CONCERNING THE TESTIMONY OF KEVIN KILSTROM**

On the 19<sup>th</sup> day of March 2020, came Plaintiff Directional ONE Services Inc., USA ("Directional One"), by its counsel, Christopher Kamper and Sean P. McGinley, and Defendant Antero Resources Corporation ("Antero"), by its counsel, W. Henry Lawrence and John D. Pizzo, for a telephonic pretrial conference. The Court heard oral arguments by both parties pertaining to Directional One's Motion in Limine and/or Motion to Compel Concerning the Testimony of Kevin Kilstrom, which asked the Court to either prohibit Antero from eliciting testimony from Kevin Kilstrom pertaining to information he obtained after his retirement regarding Directional One's invoices or to compel Antero to produce all communications between Kevin Kilstrom and Antero and between Kevin Kilstrom and counsel after August 16, 2019. The Court then requested supplemental briefing on the Motion to Compel the communications, which the parties submitted on May 4, 2020. After hearing the parties' oral arguments and reviewing the briefs, the Court

**ORDERS** that Directional One Services Inc. USA's Motion in Limine and/or to Compel Concerning the Testimony of Kevin Kilstrom is **DENIED**.


